Restrictions on purchases and withdrawals

Assets invested in the Global RETFund, International Stock Fund, and Emerging Markets Equity Fund must remain invested for 5 business days or a 2% redemption fee will apply to your transfer. For example, if you request a transfer into the Global RETFund on Thursday prior to 4 p.m. ET, you could transfer out of the same fund after 4 p.m. ET the following Thursday, if there are no holidays, without incurring a redemption fee.

In addition, restrictions are imposed with respect to transfer into the Honeywell Common Fund. Specifically, if a portion of a Plan Account is transferred out of the Honeywell Common Stock Fund, transfers into the Honeywell Common Stock Fund are restricted (prohibited) for five business days following the transfer out of the Honeywell Common Stock Fund. A transfer out of the Honeywell Common Stock Fund may be triggered by a transfer, reallocation, or rebalance which results in a net transfer of assets of the Honeywell Common Stock Fund. Payroll contribution, loan repayments, and withdrawals are not impacted by this rule. In addition, the portion of your Plan account attributable to Company Contributions may not be transferred from the Honeywell Common Stock Fund until these Company Contributions become fully vested.

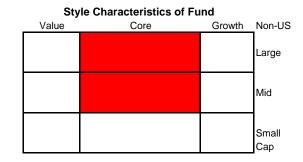

Fund Objective: To seek to achieve rates of return, over an extended period of time, representative of stocks of companies headquartered outside the U.S. in emerging markets countries. There is no guarantee the Investment Objective will be met.

Investment Strategy: The Emerging Markets Equity Fund seeks to earn returns that approximate those of the Morgan Stanley Capital International (MSCI) Emerging Markets Index - a commonly used benchmark for measuring performance of emerging markets (non-U.S.) stocks. The MSCI Emerging Markets Index consists of 23 emerging markets countries located in Europe, Asia, Latin America and Africa. The Emerging Markets Equity Fund invests in a pooled index fund that seeks to track the performance of the MSCI Emerging Markets Index. The Emerging Markets Equity Fund is a passively managed index fund from BlackRock, Inc., formerly Barclays Global Investors.





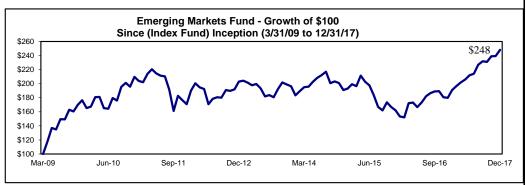
